LEH: Kushok Bakula, the architect of modern Ladakh, dreamed of establishing an institution to preserve the rich culture and unique identity of Ladakh. His dreams finally came true when the Central Institute of Buddhist Studies (CIBS) was instituted in 1959 to develop the personality of the students by instilling the values of Buddhist philosophy, literature and arts in them.

Six decades down the line, the situation at CIBS is different now because of the growing concerns over the proper functioning of the institution and the issues faced by students.

Students are raising their voices against the non availability of permanent registrar and examination controller, although the issue about Class 10 & 12 certificates has been resolved.

While interacting with the Additional VC, Professor Baidyanath Labh on telephone, he said, "I am very much concern about CIBS and putting every effort to make this institution function as per the norms of UGC. The issues faced by the students are being addressed and we are finding solutions at various levels. The issue of who will sign the Degrees is being resolved for now as the Registrar of Nava Nalanda Mahavira will be signing the degrees. To get everything systematically in CIBS we need a time but at the same time we are facilitating the students with some alternate solutions".

Urgyan Tsultrim, a CIBS student, said, "It is not only CIBS students but a matter of concern for the whole of Ladakh. We

Chief Guest of the occasion, Jamyang Tsering Namgyal said, "People of Ladakh speak Ladakhi more than Hindi but don't ignore the language completely. Being a citizen of India, we have proudly

accepted Hindi as a language".

He thanked DIHAR for taking the first initiative in Ladakh and said that it will not only benefit science but will also help in understanding science in easier way. At last he urged the participants to enjoy Ladakh by understanding the culture of Ladakh during their three day visit.

S.K Mehta, Vice-Chancellor, University of Ladakh said, "I went to foreign countries like Germany and Japan for studies. I used to amaze that they use their own language for everything. They speak in their language and even use their language in higher studies. Then I used to think that why we do not use our language

properly. So I think promotion of Hindi in India is very important because it is said that the country with rich language has a strong civilisation and culture as a byproduct. Therefore we should not be ashamed of speaking Raibhasha Hindi instead we must be proud of it. I am sure that there will be a day when the people who can't speak Hindi will be ashamed of themselves."

He further said that it is a matter of pride that all offices of DRDO are using Hindi. We have to remember that if the country lost its language then it will also lost its civilisation and culture.

Director, DIHAR, Dr O.P Chaurasia thanked the experts and scientist for their participation in the seminar. He said that following the directions of Government of India, DRDO is working to promote Hindi as a language in the field of science and technology.

He informed the audience about technical sessions on various topics including engineering and agriculture. He urged the participants to experience the high altitude of Ladakh.

always talk about culture preservation, but many have forgotten that institutions such as CIBS have taught the culture and tradition of Ladakh. While talking about promoting our language, it is important to mention that Bhoti teachers in most of the schools of Ladakh are alumni of CIBS".

"Can we afford to neglect CIBS and talk about preservation and promotion of language, art and culture?" he questioned.

Padma Tashi, President SWC, CIBS said, "Though the issue of Class 10th and 12th certificates have been resolved after the re affiliation with Sampurnanand Sanskrit University but the students are still facing the issue while applying for scholarships and online admission because the name of the board is not available in the options."

Additional VC said that the issues of board has been taken up with the Lieutenant Governor R K Mathur and hopefully the matter will be sort.

in 2016 for five years under the de novo category by the Ministry of Human Resource Development, Govt. of India (Notification no. F,9-5/2001-U3(a), Date 15 January 2016).

Initially, this news met with great fervor, but students claim the problems started thereafter. Students have been staging protests on various issues faced by them at all levels from the beginning, including the demand for recognised certificates, implementation of UGC rules and regulation and the recently advertised notification for the post of Vice-Chancellor. The air of uncertainty among the students of CIBS seems not to be fading away.

On November 15, Ladakh Buddhist Association and All Ladakh Gonpa Association, along with CIBS students' representatives, met the Lieutenant Governor of Ladakh, R K Mathur, to discuss the issues of CIBS.

While interacting with the media, Thupstan Chhewang said, "With the appointment of additional

CIBS got the status of a deemed to be a University Vice-Chancellor, Prof Baidyanath Labh, all of us and soon will have Central University for these subhoped that the issues of CIBS will be resolved. Unfortunately, the situation is completely different."

> He reiterated that the CIBS was set up to preserve and promote the Nalanda tradition of Buddhism education in Ladakh so that one can attend the Buddhist higher studies in Ladakh without going to other regions like Bylakuppe, Dehradun, Bhutan

> He said, "There is an order from the Supreme Court stating that the CIBS is for the preservation and protection of Nalanda Tradition. But the notification for the post of VC has ignored important qualifications like a doctorate in Nalanda Tradition and knowledge of Bhoti language, etc."

"The plan for introducing other departments like Hindi and English in CIBS by the additional VC also looks like an effort to reduce the importance of the institution. We already have Ladakh University

jects. Govt is trying to convert CIBS into a normal University which is unacceptable", he added.

The recent changes at CIBS contradict the sole purpose for which they set it up, he added.

Talking about the VC post advertisement and the introduction of Hindi and English department, Professor Baidyanath Labh said, "CIBS is a university and it has to function as per the norms of UGC. The advertisement of VC post is notified according to the norms of UGC by the Ministry, there is no personal motive in it. Secondly, the teaching of Hindi and English languages is very much specified in the objectives of the CIBS."

"The protests of the students are instigated, along with criticism we also need to understand the positive approaches initiated in CIBS", he added.

On one hand, the government announced a central university, medical colleges, engineering colleges in Ladakh, but the irony is that the existing institutes are going on with uncertainty.

Five-days Capacity Building Programme on General Financial Rules, Public Procurement held

LEH: Five-day training programme on GFR and Public Procurement to improve the implementation and capacity building on general financial rules and public procurement commenced on November 22

The capacity building programme has been organised by the Indian Institute of Public Administration (IIPA) in collaboration with the General Administration Department, Union Territory of Ladakh.

Dr. Surabhi Pandey, Programme Director, IIPA, and S.N Tripathi, Director General IIPA, inaugurated the event.

The objective of the five-day training is to sensitize the participants about the changes made in the orders in GFR 2017 relating to public procurement, procurement of goods using government funds, contract management e-procurement, GeM, and budget, grant in aids, and bank guarantees.

Joint Director (Finance), ISTM, DOPT, New Del-

hi, B Dhanesh, spoke on General Financial Rules and basic principles of public procurement mentioned in general financial rules, procurement, fundamental principles of public buying, procurement process, public procurement cycle, procurement objectives, basic aims of procurement, purchase procedures, up to ₹25000, local purchase committee, ascertaining the reasonableness of rate, quality, specifications and identifying an appropriate supplier and recording the certificate by Local Purchase Committee.

Ex-Deputy Director and Faculty, ISTM DOPT, New Delhi, Nafe Singh spoke on budget preparation and implementation in Government, objectives of the government budget, budgetary process in seeking approval of Parliament, principles of Budgeting, three funds, the structure of the budget, and accounts in government, functional classification, the primary unit of appropriation, preparation of RE and BE, the budget of Ladakh during 2021-22, cash management, etc.

In Kargil, trainer Shrish Ojha gave a detailed presentation on General Financial Rules, 2017 on procurement of goods. He also discussed the model Request for Proposal (RFP) template for procurement of goods and services.

General Financial Rules (GFRs) are a compilation of rules and orders of matters of the Government of India to be followed by all while dealing with matters involving public finances. These rules and orders are treated as executive instructions to be observed by all departments and organisations under the government and specified bodies except otherwise provided for in these rules.

Advisor Narula reviews winter stocking for Ladakh

LEH: Advisor Ladakh, Umang Narula reviewed the position of winter stocking of the essential commodities in Leh and Kargil districts.

During the meeting, the itemwise stocking position of different departments, including Food, Civil Supplies and Consumer Affairs (FCS&CA), Food Corporation of India (FCI), Cooperatives, Health, Power Development Department, Forest Division, Animal/ Sheep and Fisheries and the stock position of Hindustan Petroleum Corporation Limited (HPCL) and Indian Oil Corporation Limited (IOCL) were discussed in detail.

It was also informed that sufficient stock of all essential items, including food grains, fuel like petrol, diesel, kerosene, hard coke and medicines, animal feed and fodder, are available with both Leh and Kargil districts.

Executive Councillor, Cooperatives, LAHDC Kargil put forth

a few issues regarding winter stocking which were duly noted by the concerned UT officers. Earlier, Advisor Ladakh urged all the concerned officers to ensure all the essential commodities like food grains and fuel are dispatched to the inaccessible areas like Zanskar and Lingshed in winter at the earliest and all items are well stocked up till April 2022 to overcome any unforeseen delay in road opening next year.

Advisor Ladakh directed the Deputy Commissioners to prepare a detailed distribution plan of essential commodities to ensure fair and equitable distribution covering both districts. He also advised the concerned officers to form squads for regular market inspection to monitor rates and the sale of expired and rotten products.

Secretary, Saugat Biswas applauded the collaborative efforts of the Industries and Commerce Department, Ladakh and ODOP, Invest India for organising such important workshops.

District Tobacco Control Cell, Leh, discusses agendas on tobacco control

Leh: District Tobacco Control Cell (DTCC), Leh discussed the agendas on tobacco control in the district during a meeting on November 23.

The meeting was chaired by Deputy Commissioner Leh, Shrikant Balasaheb Suse.

The formation of Cigarettes and Other Tobacco Products Act (COTPA) enforcement squads at district HQ and blocks was proposed in the meeting. Displaying COTPA 2003 on the district official website and action against the supply and distribution of illegal tobacco products were discussed along with the plan of COTPA to be included in the monthly crime review of the Police Department.

The Health Department authorities suggested the 'Continuation of Yellow Line' campaign and implementing tobacco-free educational institutions guidelines.

Member of DTCC also discussed action against COTPA violations, including imposing a fine of ₹ 500 under Section 4 for smoking in public, whereas for the owner, manager, or authorized officers, the fine placed will be equivalent to the number of offences in public places; a fine for advertising of cigarettes and other tobacco products that includes 1st Offence: 2 years/ ₹. 1000/b) 2nd Offence: 5 years/₹ 5000 under Section 5.

Similarly, the other penalties include a fine up to ₹ 200 under Section 6 for the sale of tobacco to minors and around educational institutes; violation of the sale of cigarettes and other tobacco products without specified health warnings under Section 7, 8, and 9. The fine includes Manufacture: 1st Offence: 2 years/ ₹ 5000; 2nd Offence: 5 years ₹ 10,000/b) Selling/Retailing: 1st Offence: 1 years/ ₹ 1000/ 2nd Offence: 2years/ ₹. 3000/.

Harvesting marks the onset of autumn in most parts of Ladakh, where only limited crops adapts in this high-altitude cold desert region and are grown throughout the year. The main cereal crops are barley or wheat, while others include pulses like local lentils, peas, and mustard seed. The crops are grown in fields, fed with river/stream water descending from high mountain glaciers from the month of April onwards. Harvesting is not just the mere process of gathering the crops, but reaping the rewards of all the hardwork put in throughout the year.

Harvesting in the present day looks very different from the earlier times. Earlier it is more of a communal activity wherein the neighbors and relatives of the field owner would gather and assist the whole process. The family had to ensure that the guests cum helpers are fed well. The day would start with a couple of hours of work, before breakfast is served. Breakfast is accompanied with a lot of laughter and storytelling and the same is true for all the meals and tea breaks, before they move to the fields again. Harvesting was carried out with help of hand held sickles and every hand movement followed with a beat of a traditional song. It's more like a picnic with work. Crops were tied into small bales with a special knot which looks similar to the knot on the waistband of traditional dress, 'sulma'. The tied bales are then collected at one place for drying. After the crop dries, threshing is done with the help of animals. Every household has a special circular land earmarked, with a pole in center, where the animals, usually dzos (a yak-cow hybrid), bulls, cows, or horses are tied and made to walk around, on top of the dried crops, dislodging the dried grains from the chaff. Threshing is followed by winnowing, done with the help of wind and a long handmade wooden rake, accompanied with whistling music.

Agriculture processes like harvesting sowing etc. are becoming no longer a communal activity. Earlier being dependent on each other for most work encourages cooperative social behaviors thus creating immense social harmony. Nowadays, hand held sickles have been replaced by portable chainsaw-like machines powered by gasoline, the busy schedules of neighbors and relatives compels to hire paid laborers to do all the work and threshing is done with a threshing machine, the thresher. The influx of money and machines, families becoming more independent from the society for labor seems to be bringing more of a individualistic society slowly, the repercussions of which are evident in an increasingly more self-centered approach to things.

Amidst growing changes and modernization, the old traditional way of harvesting are still practiced by many villages. One cannot be sure for how long this will persist given the rapid pace of change everywhere. A challenge for today in Ladakh is to retain, and regenerate where needed modify the beautiful and ecologically sustainable communal,

reciprocal harvest methods and ethos amidst this change.

Local Futures have been organizing 'Volunteer for Harvesting' events for the last few years. We ask locals, travelers and students to come and help farmers in villages for the harvesting. When travelers go to help a farmer in harvesting, they pay for their stay, food and also help them in the harvest. Otherwise, due to urban migration, very few villagers are available to help in harvesting, and hiring of laborers costs a lot of money. Almost all the young family members from every family live in Leh town for their kids' education or for jobs in the private and government sector. Only the elders members of the family are left in the villages to do all the household and farming chores. Many families have already left farming because of manpower shortages. Families who are still practicing farming need help to continue it. Otherwise, in the coming years, it will be difficult to find a farmer practicing traditional methods. Thus, with an aim to encourage traditional farming practices, Local Futures 'Volunteer for Harvesting' project contributes a small part by helping farmers to continue their work and maintain the viability of villages. This year, we organized the 'Volunteer for Harvesting' event in Gya Village, but unlike previous years where many volunteers were foreign tourists, this year was different, because we all were young local students. This time we got some members of LSWSD (Ladakh Student Welfare Society Delhi) who volunteered with us, and for some of them it was their first time working in a field. They feel unfortunate being born and raised in a town, with no agrarian experience.

In Gya, we helped Acho Urgain (one of the progressive farmers of Ladakh) who has been experimenting in growing variety of vegetables and practicing organic farming throughout his life. Gya 80km east of Leh is a village which still values the old tradition of harvesting and can be witnessed even now with minimal use of modern methods, for example tractors for transportation. With time the practice of traditional harvesting is taken over by modern technology. Though the machines consumes less time but the appreciation and acknowledgment of our local culture is subsequently vanishing. To keep the old traditional way of living ongoing with change we organise such activity.

Along with field work we also discussed the effect of urban migration on villages, which are going to get worse if we don't reflect on it. Looking at our enthusiasm, villagers were very welcoming and patient in guiding us while working on the field. It helped us bond, understand and appreciate their lifestyle and commit to preserve the local, traditional farming system into the future.

In Conversation with

Rigzin Dorjai Yarma, Project Coordinator, Live to Rescue

Interviewed by Stanzin Dasal

Q. Brief us about Stray Animal Care and Management Centre (Live to Rescue).

In the year 2014, fatal dog attack cases were reported in many parts of Leh district and the rising cases resulted in a human-animal conflict. The lives of stray dogs were under threat, many innocent animals were poisoned, thrown in a river, etc. The inhumane attitude of the people towards dogs and rising dog attack cases saddened His Holiness Gyalwang Drukpa and emphasized strongly to curb the feral dog population through Animal Birth Control and to rescue, treat, care, and shelter injured, sick, and abandoned dogs. Stray Animal Care and Management Centre came up with such aims under the guidance of His Holiness Gyalwang Drukpa and His Eminence Thuksey Rinpoche. The centre was established in Nang village and the land was donated by the villagers of Nang to His Holiness.


At present around 260 dogs are taken care of and apart from that 70 other animals including donkeys, horses, goats, bulls, cows, and other animals that are abandoned or injured are taken care of.

Sick, injured, and abandoned animals recommended by Vet doctors of the Animal Husbandry department are sheltered at the centre. Live to Rescue is available round the clock to attend to animals that are in distress. We have gone to Nyoma village of Changthang region, Khaltse in Sham belt to rescue animals.

The centre continues to work with the help and support of His Holiness, His Eminence, Animal Husbandry Department, Municipal Committee, Leh, and volunteers. We get a sufficient amount of feed for the animals from different parts of Ladakh, leftover food from Grand Dragon hotel, small donations from people. With everyone's help and support, we will continue to help the voiceless.

O. Stray dog menace is one of the concerns in society. How Live to Rescue is working on reducing the dog menace?

Partnering with Hill Council, Leh, Animal Husbandry Department, Municipal Committee we are working proactively in dog population management. A clinic for animals mainly catering to animal birth control (ABC) of stray dogs has been set up in Changspa, Leh. Pre and post-operative care of the neutered dogs are taken care of at the clinic including treatment of stray dogs and animals. Also, we have a small solarised OT at the centre in Nang with a needed facility to perform the sterilization of dogs. The doctors are from the Animal Husbandry Department have supported us immensely.

Abandoning animals such as donkeys, bulls, and horses is a big concern. In time of need, these animals are sheltered and later when the work is done they are left on streets and roads. This is very disheartening because these abandoned animals are left out get attacked by stray dogs, hit by vehicles, and roam around in garbage piles for food. Also, in a day we come across three to four accident cases and many animals are left injured on roads. Many people refuse the ownership of abandoned animals also.

There are different people in this world; some are concerned about animals while some are least bothered.

Q. Brief us about the plans of Live to Rescue. What advice will you give to the people?

We are looking forward to aware people of animal rights and welfare especially in schools but due to COVID the programme is held up. We had a meeting with Hill Council, Leh, and CEC, Hill Council, Leh Tashi Gyalson assured all kinds of support to keep the work ongoing. Live to Rescue aims to shelter every animal that is left abandoned. Apart from us, there is a few more organisation who are working for the welfare of animals, together we all can make the animals also live in peace and harmony.

I would like to appeal to people to be kind to animals and while feeding the stray animals kindly keep the food away from roads because it is one reason the animals are hit by the vehicles.





Under the New and Renewable Energy sector, the memorandum highlights, solarised water lifting in several villages of Leh district under the Pradhan Mantri Kisan Urja Suraksha even Utthan Mahabhiyan (PM KUSUM) Scheme, major concerns regarding the upcoming 10 GW Solar Power Project at Pang, Changthang, provisions such as environmental/ social impact assessment of the project, livelihood security, transparent solar panel as an option, recycling plants for waste man-

agement, skill-based training for locals, and technical/non-technical job reservation for locals in the project.

Minister, RK Singh assured to address all the major concerns at the earliest.

With the Union Minister for Housing/Urban Affairs & Petroleum, Natural gas, Hardeep Singh Puri, CEC, Leh discussed issues related to the management of Solid and Liquid waste management and the overall water-lifting scheme for 24*7 drinking water provision in Leh town and adjoining areas.

Wearing face masks, maintaining social distancing, provision of thermal scanning and use of hand wash or sanitizer would be mandatory. These gatherings shall also be monitored and in case of violation of physical distancing and mask usage norms, necessary enforcement, and penal actions will be taken by magistrates/police and special Covid

squads.

As a matter of abundant caution, no mass gatherings will be allowed in areas identified as containment zones. Marriages (attended by up to 50 persons) and funerals/last rites (attended by up to 20 persons) will be allowed outside the containment zone with the prior permission of the office of District Magistrate Leh.

Chairman DDMA Leh further impressed upon the officials to ensure that these guidelines issued by the State Disaster Management Authority (SDMA) are strictly enforced in the district. He added that all protocols issued by State Executive Committee (SEC), Ladakh Disaster Management Authority (LDMA) should be strictly adhered to.

He further appealed to the public to always follow Covid Appropriate Behaviour.

District Police, Leh, confiscate illegal liquor, 3 held

LEH: District Police Leh recovered around 304 bottles of illicit liquor from two different locations around Leh town on November 26.

Three women namely Phurpa Dolma, Sunita Kesi, and Kesang Dolma resident of Nepal were arrested. The case was registered under FIR No. 264 under section 48A Excise Act.

Inspector Mohd. Yousuf, SHO, Leh informed about the operation launched by Leh Police against illegal liquor. He said that the people involved in such a case used to stock the bottles when it is available in wine shops and sell them charging double the price when there is a shortage of liquor in the market.

He also informed that police have a separate monitoring cell in the district with source and come into action whenever such information is received. Talking about the conviction rate he said in such cases it remains 99percent because the matters are solved by fine or whatever the punishment stated as per law.

Earlier on November 2 police ceased 312 bottles of illegal liquor from Choglamsar and 270 from Spituk. The case was registered under FIR no. 255 under section 48A Excise Act. The cases are under trial.

Inspector Yousuf further added that the police are patrolling day and night to ensure peace and security.
